B. Besides above conditions, institutions seeking approval of Pharm.D / Pharm.D (Post Baccalaureate) course shall comply with the following conditions -

- The institution shall comply with the requirements of Pharm.D. Regulations, 2008 particularly regarding appointment of teaching staff, equipments and Hospital facility.
- Further the PCI recommends that Pharmacy Practice Faculty including HOD shall undergo at least 1 Continuing Education Programme / Training Programme of minimum 3 days duration every year and participation in atleast one seminar/conference every year.

The minutes of 01.101st meeting of the Central Council of the Pharmacy Council of India held on 6th & 7th April, 2017 at Ooty.

* Consideration of approval of the Diploma, Degree, Pharm.D and Pharm.D (Post Baccalaureate), M.Pharm and B.Pharm (Practice) course and examination in Pharmacy.

The following resolutions moved by Shri M. Venkata Reddy, Shri Ajay Singh Rajput and Sri Ajay Phatak and seconded by Shri H.G. Koshia, Shri Neeraj Upmanyu and Shri Sunil Kumar Chaudhary were unanimously passed applicable in respect of all approvals u/s 12 of the Pharmacy Act, 1948 for the purpose of registration as a pharmacist.

A. For the approval u/s 12

- "(1) In pursuance of the provisions of sub section (1) of section 12 of the Pharmacy Act, 1948 (8 of 1948), the Pharmacy Council of India declares the course in Pharmacy (as applicable) conducted by institutions mentioned below to be an approved course of study for the purpose of admission to an approved examination in Pharmacy (as applicable) in respect of number of students and academic session as specified here under:

5. Lack of proof of payment of salary particulars for existing staff (Bank statement including TDS particulars).
6. Blacklisted/ Multiple registrations.
7. Not satisfying biometric attendance criteria.

b. Laboratory deficiency

1. Non availability / Non working condition of laboratory equipment.
2. Lack of all supporting documents for laboratory equipment.
3. Non - Fulfilment of the additional laboratory requirement.

II) As per clause: 3.30 of affiliation regulations 2018-19.


