## POLICY FOR ATTENDING FDP / STTP / WORKSHOP / SEMINAR / STIP/ CONFERENCE FOR FACULTY / STAFF WITH FINANCIAL SUPPORT

## 1. Leaves

a) Those attending FDP / STTP / Workshop / Seminar / Conference are entitled to get on-duty leave with the Principal's prior approval.

b) During this period, if any holiday / Non-working days fall, then no special Compensatory Off will be given to the attendee.

c) On-Duty leave will not be granted for attending irrelevant FDP / STTP / Workshop / Seminar / Tutorial /Conference.

d) In case the attendee remains absent during this period (for the event), there Institute will cancel on-Duty leave

## 2. Registration Fee/ TA / DA

a) In case the Institute feels that the course is helpful for the institute/department, in this case, the Institute will bear TA as admissible as per Govt. Norms. To achieve this, prior approval of the Principal is required. No DA was administered.

b) If the program is in Vijayawada, no LCA will be performed.

c) Registration Fee will be reimbursed, not more than Rs. 5000/- in total for the academic year, in case a program is within India and Rs. 15000/- in total for abroad

d) Submitting claim original bills/tickets need to be submitted.

e) For attending irrelevant FDP / STTP / Workshop / Seminar / Tutorial / Conference - registration fee, TA, or DA are not applicable

## 3. Conditions

(a) For research paper publication, plagiarism must be less than 20%.

(b) To encourage the faculty towards research, Siddhartha academy provides cash incentives for publications in Scopus Indexed Journal without Thomsons Reuters

Thomson Reuters Impact Factor <1 (6000/-), UGC approved journals having ISSN number (1500/-).

c) In an academic year, one FDP and one seminar/conference will be sponsored by Siddhartha Academy for those who presented.

(d) For those faculty who won a prize, full reimbursement will be given by the Siddhartha Academy for their encouragement.
